Privacy Policy

www.excellenceit.com.au is a website (website) of Excellence IT (we, our and us in this Privacy Policy). By using this website or supplying information to us by other means, you agree to this Privacy Policy. This Privacy Policy relates to the collection and use of personal information you may supply to us through your conduct on the website or by other means.

We reserve the right, at our discretion, to modify or remove portions of this Privacy Policy at any time. We will notify you of these changes by publishing them on our website.

This Privacy Policy is in addition to any other terms and conditions applicable to our website or set out in any agreement that we have with you. We do not make any representations about third party websites that may be linked to the website.

We recognise the importance of protecting the privacy of information collected about visitors to our sites or which is supplied to us, and in particular information that is capable of identifying an individual (**personal information**). Examples of personal information include: names, addresses, email addresses, phone and facsimile numbers. Personal Information also includes 'sensitive information', which is defined in the Privacy Act 1988 (Cth) (**Privacy Act**) to include information or opinion about an individual's racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

PERSONAL INFORMATION

Personal information is collected only when knowingly and voluntarily submitted. For example, we may need to collect such information to provide you with services or to answer or forward any requests or enquiries. We also collect statistical information about visitors to our website.

USE OF INFORMATION

Copies of correspondence sent from the website that may contain personal information are stored as archives for record-keeping and back-up purposes only. You should be aware that providing information to third parties through our website will result in the information being passed to those third parties which we may have no control over, and your information will then be held subject to the privacy obligations of that organisation which may not conform with this Privacy Policy.

DISCLOSURE

Apart from where you have consented or disclosure is necessary to achieve the purpose for which it was submitted, personal information may be disclosed in special situations where we have reason to believe that doing so is necessary to identify, contact or bring legal action against anyone damaging, injuring, or interfering (intentionally or unintentionally) with our rights or property, users, or anyone else who could be harmed by such activities. Also, we may disclose personal information when we believe in good faith that the law requires disclosure.

We may engage third parties to provide you with goods or services on our behalf. In that circumstance, we may disclose your personal information to those third parties in order to meet your request for goods or services.

We do not sell your personal information to third parties.

You may unsubscribe from our mailing/marketing lists at any time by contacting us in writing.

SECURITY

We strive to ensure the security, integrity and privacy of personal information submitted to our sites, and we review and update our security measures in light of current technologies.

Unfortunately, data transmission over the internet cannot be guaranteed to be totally secure.

However, we will endeavor to take all reasonable steps to protect the personal information you may transmit to us or from our online products and services. Once we do receive your transmission, we will also make our best efforts to ensure its security on our systems.

In addition, our employees and the contractors who provide services related to our information systems are obliged to respect the confidentiality of any personal information held by us.

However, we will not be held responsible for events arising from unauthorised access to your personal information.

When your personal information is no longer needed for the purpose for which it was obtained, we will take reasonable steps to destroy or permanently de-identify your personal information. However, most of the personal information is or will be stored in client files which will be kept by us for a minimum of 7 years.

COOKIES

Cookies are data that a website transfers to an individual's hard drive for record-keeping purposes. consent or otherwise complying with the APPs, which require, among other things, that we

consider the recipient to be bound by legislation similar to the APPs and we have a contractual

mechanism with them to enforce your rights.
